

Privacy Policy

This Privacy Policy has been compiled in accordance with the General Data Protection Regulation (Regulation (EU) 2016/679 of the European Parliament and of the Council) and the Personal Data Protection Act and is applicable to **Höbenool OÜ** customers and potential customers who have requested that.

The Privacy Policy is an integral part of contracts to be entered into between Höbenool and the customer and contains the following information:

- the type of personal information we collect;
- why and on what basis we collect your personal information;
- how we handle your personal information;
- your rights;
- our contact details so that you can receive information about your rights regarding the processing of your personal data and exercise those rights.

Useful definitions

For the purposes of these rules, Höbenool uses the following terms:

Customer - a natural or legal person who uses, has used or has expressed a desire to purchase the goods and services offered by Höbenool or is otherwise connected with the services of Höbenool.

Data subject - a natural person about whom Höbenool has information to identify the person. Data subjects include, for example, individual customers, visitors, inquirers and questioners / requesters, business partners, legal customer representatives and, in the case of rental service, the details of the rental car user, in addition to those of the lessee. Also referred to as a **person** or **customer** in this privacy policy statement.

Personal data – any information relating to an identified or identifiable natural person ("data subject").

Processing – any automated or non-automated activity consisting in collecting, documenting, organizing, structuring, storing, adapting and modifying, making inquiries of, reading, using, transmitting, disclosing by dissemination or otherwise making available, restricting, combining or merging, deleting, and destroying personal data or sets of such data .

Personal Data

Höbenool processes customers' personal data only on the bases and for the purposes set forth in the Personal Data Protection Act and this Privacy Policy. Höbenool processes the following personal information of customers:

Høbenool collects the above data in different ways:

- information disclosed by the person to Høbenool (eg through inquiries, requests and contracting), data resulting from communications (eg through correspondence, telephone calls, disclosed verbally and otherwise, which shall be recorded accordingly);
- information disclosed by the individual on the Internet and social media;
- information received on payment for goods and services (card payments, bank transfer information, etc);
- data received from third parties - from public registers, authorities (eg Road Administration);
- previous information on the person and vehicle stored in the databases of Høbenool;
- visits to the website of Høbenool (eg on the person's browser and operating system used, details of the website visit (date, time, notification on opening various pages, error messages, opening frequency, movements to and from the website of Høbenool). In addition, for security purposes, in particular to prevent and detect attacks and fraud attempts on the website, the IP address of the person and the name of the Internet service provider are recorded.
- Information from GPS devices in rental cars, camera recordings in the offices and workshop of Høbenool to protect the assets of Høbenool.

Purpose and basis of data processing

Høbenool has a legal basis and interest in processing personal data of customers or customer representatives during the establishment, duration and termination of collaboration and customer relationship, and to maintain personally identifiable information throughout the process, including for legal obligations, claims, and litigation.

Høbenool collects and processes personal data primarily in situations and for purposes as follows:

The created video material and photos are the property of Hőbenool and Hőbenool has the right to use and publish such material at its sole discretion on the website, social media and public media; |

Access to Personal Data and Security

Hőbenool guarantees the confidentiality of customer data required by law and protects personal data against unauthorized access, unauthorized processing or disclosure, accidental loss, alteration or destruction.

Only the legal representatives of Hőbenool or its designated employees have access to personal data. Certain personal data may be transferred to a third party, ie to an authorized processor, for the purpose of fulfilling contractual and legal obligations (see data sharing below).

Höbenool organizes the exchange of all information in a secure manner, using multiple personal access and identification codes and secure communication channels, thus preventing access by third parties and minimizing the risk of data leakage.

Data Sharing

Höbenool transmits the customer's personal data to third parties, if required by law, necessary for the operation of Höbenool, or for performing its obligations or rights arising from law or on any other legal basis. Personal data submitted to authorized processors shall be processed on the grounds provided by law and only to the extent necessary.

Höbenool transfers personal information to the following recipients:

- authorized processors for organizing the operation of Höbenool (eg for the accounting service provider, IT systems manager, eg client program manager, business software, accounting software, archiving service, etc);
- authorities (law enforcement agencies, bailiffs, bankruptcy trustees, notaries, court, road administration, etc);
- third parties involved in the sale of goods, provision of services and performance of the contract with the customer - payment agents, various lessors, providers of communication, IT and postal services , courier service providers, advertising and marketing specialists;
- legal advisers, financial advisers, insurers;
- new creditor in case of assignment of the right of claim;
- camera security provider and GPS service provider for rental cars.

Personal Data Retention and Time

Höbenool does not process personal data for longer than necessary for the fulfillment of the purposes related to the respective data, including fulfillment of the data retention obligation established by legislation.

- Customer contract information is retained for three years.
- Statutory accounting records and data are kept for seven years.
- Information obtained by consent shall be kept until the consent is withdrawn.

The customer has the right to withdraw his / her consent at any time by submitting a notice to the Höbenool office by e-mail or physically on site. The withdrawal of consent shall not affect the lawfulness of the processing of personal data prior to the withdrawal of the consent.

Personal data are processed within the European Union / European Economic Area. Should there be a need to process personal data on external servers, transfers will only be made to recipients located in a country with an adequate level of data protection pursuant to an appropriate decision of the European Commission or recipients certified under the data protection framework Privacy Policy (applicable to recipients located in the USA).

Customer Rights

The customer has the following rights in connection with the organization of personal data protection in Höbenool:

- examine personal information and, if necessary, obtain a copy of the data;
- require the correction of outdated or incorrect data;
- require the deletion of data or cessation of data processing where there is no legal basis for the storage or processing of personal data and where personal data are no longer required for processing;
- require the transfer of data to a third party;
- right of appeal to a supervisory authority.

To use the above rights, contact an office of Hõbenool. If the customer has any suspicion of misuse of his / her personal data, he / she must immediately inform the office of Hõbenool.

Hõbenool has the right to update and change the privacy policy. Changes will be made available to customers on the website of Hõbenool.
